A RESOLUTION OF STATE ROAD 100 CORRIDOR COMMUNITY REDEVELOPMENT AGENCY (SR 100 CORRIDOR CRA) OF THE CITY OF PALM COAST, FLAGLER COUNTY, FLORIDA, AMENDING THE FISCAL YEAR BUDGET 2020-2021 RELATING TO APPROPRIATION OF FUND BALANCE; AND PROVIDING SEVERABILITY. **PROVIDING FOR** CONFLICTS. PROVIDING FOR IMPLEMENTING ACTIONS, AND PROVIDING AN EFFECTIVE DATE

WHEREAS, the Board of the SR100 Corridor CRA of the City of Palm Coast, Flagler County, Florida desires to make an investment of \$1,000,000 forgivable performance loan to assist Jacksonville University opening an off—site campus location in Palm Coast Town Center, and

WHEREAS, this forgivable performance loan is in accordance with the SR 100 Corridor CRA plan as amended in 2018 originally adopted in 2004; and

WHEREAS, the SR 100 Corridor CRA of the City of Palm Coast, Florida desires to amend the SR100 Corridor CRA Fiscal year 2020-2021 budget to appropriate \$1,683,602.

NOW, THEREFORE, BE IT RESOLVED by the SR 100 Corridor CRA of the City of Palm Coast, Flagler County, Florida, that:

SECTION 1. LEGISLATIVE AND ADMINISTRATIVE FINDINGS OF SR 100 CORRIDIOR

CRA. The above recitals (whereas clauses) are hereby adopted as the Legislative and Administrative Findings of the SR 100 Corridor CRA of the City of Palm Coast.

SECTION 2. APPROVAL AND APPROPRIATION. The SR 100 Corridor CRA of the City of Palm Coast approves amending the Fiscal Year 2020-2021 budget in the amount of \$1,683,602 to appropriate the fund balance, as attached hereto and incorporated herein by reference as Exhibit A – SR 100 Corridor CRA.

SECTION 3. SEVERABILITY. It is hereby declared to be the intention of the City Council that the sections, paragraphs, sentences, clauses and phrases of this Resolution are severable, and if any phrase, clause, sentence, paragraph or section of this Resolution shall be declared unconstitutional by the valid judgment or decree of a court of competent jurisdiction, such unconstitutionality shall not affect any of the remaining phrases, clauses, sentences, paragraphs and sections of this Resolution.

SECTION 4. CONFLICTS. All resolutions or parts of resolutions in conflict with this Resolution are hereby repealed.

SECTION 5. IMPLEMENTING ACTIONS. The City Manager is hereby authorized to take any actions necessary to implement the action taken in this Resolution.

SECTION 6. EFFECTIVE DATE. This Resolution shall take effect immediately upon adoption by the SR 100 Corridor CRA.
