Background:

City Council adopted the Fiscal Year 2025 Budget on the 25th day of September 2024 per Resolution 2024-151.

Per State Statute 166.241, section 8, the governing body of each municipality at any time within the fiscal year, or within 60 days following the end of the fiscal year, may amend a budget for that year.

The Water/Wastewater Utility Capital fund expenditures will exceed the original budget for Fiscal Year 2024-2025 by \$1,229,904.00 in order to accommodate funding for needed capital projects.

This increase in budget requires City Council to amend the Fiscal Year 2024-2025 budget from \$83,838,019 to \$85,067,923.

RESOLUTION 2025-108 FISCAL YEAR 2025 BUDGET AMENDMENT WATER/WASTEWATER UTILITY CAPITAL PROJECTS FUND

A RESOLUTION OF THE CITY OF PALM COAST, FLORIDA, AMENDING THE FISCAL YEAR 2024-2025 BUDGET RELATING TO WATER/WASTEWATER UTILITY CAPITAL PROJECTS FUND REVENUES AND EXPENDITURES; PROVIDING FOR SEVERABILITY; PROVIDING FOR CONFLICTS; PROVIDING FOR IMPLEMENTING ACTIONS AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, on September 25, 2024, City Council approved Resolution 2024-151, a resolution adopting the budget for the Water/Wastewater Utility Capital Projects Fund of \$83,836,019 for the fiscal year 2024-2025; and

WHEREAS, the City Council of the City of Palm Coast finds it necessary to amend the Fiscal Year 2025 budget for the Water/Wastewater Utility Capital Projects Fund by \$1,229,904.00 for the purpose of funding Wastewater Treatment Plant #1 Expansion & OKR South Reclaim Main Extension projects as well as to address projected expenditures for various projects within the Capital Projects Funds.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF PALM COAST, FLORIDA, AS FOLLOWS:

SECTION 1. BUDGET AMENDMENT. The City Council of the City of Palm Coast hereby amends the Fiscal Year 2024-2025 budget for the Water/Wastewater Utility Capital Projects Fund by \$1,229,904.00 to \$85,067,923 depicted in Exhibit "A", which is attached hereto and incorporated herein.

SECTION 2. SEVERABILITY. It is hereby declared to be the intention of the City Council that the sections, paragraphs, sentences, clauses and phrases of this Resolution are severable, and if any phrase, clause, sentence, paragraph or section of this Resolution shall be declared unconstitutional by the valid judgment or decree of a court of competent

jurisdiction, such unconstitutionality shall not affect any of the remaining phrases, clauses, sentences, paragraphs and sections of this Resolution.

SECTION 3. CONFLICTS. All resolutions or parts of resolutions in conflict with any of the provisions of this Resolution are hereby repealed.

SECTION 4. IMPLEMENTING ACTIONS. The City Manager, or designee, is hereby authorized to take any actions necessary to implement the action taken in this Resolution.

SECTION 5. EFFECTIVE DATE. This Resolution shall become effective immediately upon its passage and adoption.
